## A. PROFESSIONAL SERVICES OFFERED

### Basic Services of Funeral Director and Staff \$1,695.00

This is the basic charge to each family we serve. The charge is for our professional expertise and includes, but is not limited to, a proportionate share of the taxes, licenses, utilities, and business expenses necessary to serve the public community in a professional manner. Also included in this charge is the personnel available 24 hours a day, 365 days a year to respond to initial call; the consultation with the family, clerical and administrative services, coordination with clergy, cemetery, crematory, or common carrier; planning the funeral or memorial services. There will be an additional charge for the direction and supervision of each service requested or required. This fee for our basic professional service and overhead will be added to the total cost of the funeral arrangements that have been selected. This fee is already included in our charges for Direct Cremation, Immediate Burial, and Forwarding or Receiving Remains.

### Embalming.....\$475.00

Embalming is the chemical process that provides a temporary preservation of the body. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
